## **Reported Opinions:**

- In the Matter of Price, 284 S.E.2d 356, 277 S.C. 169 (S.C.1981), court held that state's failure to comply with court 40-day rule on adjudicatory hearing was not material. (Represented, pro bono, minor charged with violation).
