For a number of years, I represented several hospitals, medical practices and medical product manufacturers in hospital, health care and products related issues. I also have experience as attorney in public utility law.

In 1992, I was elected by the South Carolina General Assembly as a circuit judge and served over ten (10) years as a trial judge. Upon my retirement from the bench in 2002, I became the Assistant of Extended Stay America, Inc. and was responsible for managing major litigation for the Fortune 500 company with 675 hotels in 42 states. In this capacity, I participated in over 75 mediations in various state and federal jurisdictions throughout the country.

From 2005-2008, I served as Assistant Professor of Paralegal Studies at Greenville Technical College. Since 2008, I have conducted mediations and arbitrations and engaged in limited practice in federal court.
