Much of my practice has involved maritime and international trade law, but I have handled other types of business litigation. I have had the privilege of handing various maritime cases before judges in the District of South Carolina as well arguing maritime cases before panels of the Fifth and Eleventh Circuit Courts of Appeal. I have been a frequent lecturer on maritime law subjects, and in 2016 began teaching maritime and trade courses as an adjunct professor at the Charleston School of Law. I am an active participant in the John Brown Admiralty Moot Court competition, serving as a judge of both briefs and oral argument. In 2017 I was a Fulbright visitor to the University of KwaZulu-Natal in Durban, South Africa, where I lectured for the Maritime Studies Unit and at the annual meeting of the Maritime Law Association of South Africa. I have lectured on maritime law the past several years as part of the Intermodal Logistics program at the College of Charleston.


